Note: Dinghys must be fastened securely to the ground to ensure they will not blow over in a wind. All Members should have adequate liability insurance coverage in the event of injury or damage caused by them or their boat.

Keel Boat Member Information:

1. There can be up to 5 boats with docks on the creek, as may be decided by the Harbour Master
2. The location for each boat will be decided by the Harbour Master, based on a number of considerations, including (but not limited to):
 - a. Returning member
 - b. Keel depth – the furthest out docking spot is very shallow
 - c. Boat's and skipper's handling capability
 - d. Other relevant factors as decided by the Harbour Master to optimize the benefits for all the spots/boats
3. A Waiting List will be maintained by the Secretary Treasurer, showing the order of application for a dock spot on the creek and the date when they went on the list. To be eligible to be entered on the Waiting List a person must already be a member, and must already own the keel boat they wish to dock on the creek. Potential members and potential buyers of a boat are not eligible to go on the list.
4. Safety and Environmental Issues: Keel Boat members must agree:
 - a. to maintain their docks/walkways in a safe condition
 - b. lines to shore will be sufficient, and shore attachments will be sufficiently sturdy, to secure the boat in severe weather and other stressful conditions
 - c. to comply with all environmental and water related regulations ensuring no prohibited material gets in the creek or lake water
 - d. to examine the electricity lines above the creek and against the road (Hwy 301), and accept any liability for damages that they may cause to themselves or their boat if they should contact those electrical lines.
 - e. to examine the rocks on the sides of the creek near the road, the boat traffic, the marina docks and other hazards and confirm they accept all liability for any of these risks
5. Docks on the creek must be moveable.
6. Liability Insurance: Keel boat members must have adequate liability insurance or be self- insured in the event they or their boat causes injury/damage resulting in a liability claim
